We buried the scavenged bones out of respect. Whether the animal had been killed by his dogs or coyotes is uncertain. With such a disregard for animal life, I am concerned Andrew will act vengefully against my loved pets just in order to intimidate me.

#### CH-100 Attachment 3b - Why Others Need Protection

Andrew Nowaczek has verbally threatened me and my husband on multiple occasions. Yelling that we are trespassing (while we stand on our own property) and how because I own my property next to his, we are costing him millions. He has threatened to sic his livestock guardian dogs on us, dogs who in the past have killed his own personal sheep & goats. He has threatened me while I stood on my own property, saying "You're trespassing, and I shoot trespassers". He has attempted to infringe on our private property, removing registered survey markers and building fences and gates. He has sent threatening text messages when one of his dogs escaped his yard onto my property, saving it was my fault and I was lucky "the dog didn't kill anyone" on my property today. I take that to mean he was referring to the dog killing myself or my husband. He has called my closest neighbor (Mr M) and yelled about how my husband and I are costing him money (which I don't know how I am?), and my other neighbor (Mr P) about how Andrew will build another fence across our shared easement and restrict my ability to drive to and from my home. Most recently (8/22/2025) Andrew Nowaczek has crawled around the fence separating his property from mine, which was recorded on my security cameras, and trespassed on my property while taking pictures of my belongings in my yard. I couldn't tell if he was armed during this incursion, his clothing obscured any view of a concealed carry, but I was in very real fear for myself, my husband, and my livestock since he has threatened using firearms in the past. He left my property by crawling around the fence after about 10-15 minutes. I called the police, who came and made a report: #250822002562 with Officer Kubota (44966) and Officer Mendez (44973). During the time where the police officers were in my driveway speaking to my husband and myself, Andrew Nowaczek's vehicle could clearly be seen driving back and forth up and down his driveway. Officer Mendez commented on the unusual behavior, and I was advised by the officers to seek a restraining order. On 9/9/2025 Andrew Nowaczek physically went to my neighbor's 2nd home, where he confronted my neighbor's family and demanded that my neighbor help him damage my property, by turning off our shared city water main. My neighbor then called me, saying Andrew had been so angry, saying things about my husband and myself that weren't true, and could be considered defamatory. However this neighbor is a friend of mine, so he told me he did not believe the things Andrew was saying. I am scared that since Andrew Nowaczek is going around to my neighbors, trying to get other people to do the work of hurting me/my property, that he will continue to escalate and enact damages by his own hand.

Andrew Nowaczek crawled around the fence separating his property from mine, which was recorded on my security cameras, and trespassed on my property while taking pictures of my belongings in my yard. I couldn't tell if he was armed during this incursion, his clothing obscured any view of a concealed carry, but I was in very real fear for myself, my husband, and my livestock since he has threatened using firearms in the past. He left my property by crawling around the fence after about 10-15 minutes. I called the police, who came and made a report: #250822002562 with Officer Kubota (44966) and Officer Mendez (44973). During the time where the police officers were in my driveway speaking to my husband and myself, Andrew Nowaczek's vehicle could clearly be seen driving back and forth up and down his driveway (photo #3 in the pdf). While the officers were taking my report, they received a call over their radio and temporarily left my property to respond. The officers came back to my property after a few minutes to complete my report. During this time, Andrew Nowaczek was driving and parked up my driveway, as evident in Photo #4 in the pdf. He did not approach my house, but loitered within sight. Officer Mendez noticed the white truck behaving suspiciously, and I told him that was Andrew's vehicle. He recommended I obtain a restraining order.

I purchased my property in late 2018 with my husband Robert Bristow. In 2019, my husband and I had numerous (more than 4 separate occasions) where Andrew Nowaczek screamed at us from his yard, while we stood on our own owned property, about how we were trespassing. This was when he shouted 'You're trespassing. I shoot trespassers" In 2021 he sent text messages after one of his dogs escaped his damaged fence, blaming my husband and I, saying it was my fault and I was lucky "the dog didn't kill anyone" on my property today. I take that to mean he was referring to the dog killing myself or my husband, or any of my pet livestock. I unfortunately do not have copies of this text exchange. I have tried to avoid any altercation or interaction with Andrew Nowaczek, because I am afraid he will behave erratically and do something violent. In July I was told by my neighbor (Mr M) that Andrew Nowaczek had called and yelled about how my husband and myself were costing him so much money. Which I still don't understand how I am? Andrew Nowaczek also called my other neighbor (Mr P) threatening to cut off any vehicle or pedestrian access to the driveway by building an additional fence across our shared easement. All this information was relayed to my husband and myself by our neighbors, whom we are friendly with, which has just made us feel very stressed and anxious living next to Andrew Nowaczek. 9/9/2025 Andrew Nowaczek physically went to my other neighbor's (Mr J) 2nd home in Sylmar, where he confronted my neighbor's family and demanded that my neighbor help him damage my property, by turning off our shared city water main. Mr J then called me, saying Andrew had been so angry, saying things about my husband and myself that weren't true, and could be considered defamatory. However this neighbor is a friend of mine, so he told me he did not believe the things Andrew was saying. I am scared that since Andrew Nowaczek is going around to my neighbors, trying to get other people to do the work of hurting me/my property, that he will continue to escalate and enact damages by his own hand. I fear that eventually he will decide to escalate these intimidation tactics and I don't know what kind of thing he might do to me.
